

THE STRAIGHT SCOOP OF PERMITS

1. Go to the NJ Motor Vehicle and purchase a motorcycle permit. When you purchase the non-valid permit, you should pick up the motorcycle manual and the car manual. Keep in mind, it is a worthless piece of paper until you go back to get it validated. To validate your permit, you must successfully pass the written and vision test. You will need to study the motorcycle manual and the drugs and alcohol section out of the car manual. Your permit must be renewed every 90 days but your test scores are good for 2 years.
2. Go back to NJ MVC to take the test. If you fail the test, the MVC will make you wait a week to take the test again. Keep in mind, if you have not passed the written and vision test or have not taken the test yet, the clock is still ticking on the 90 days since the 90 day period is from the date of purchase.
3. Once you pass the written and vision test, they will validate your permit. They will mark it validated on the bottom of the permit and on the back they will put a stamp and hologram sticker that says you are valid for practice driving.
4. **It is your responsibility to make sure your permit is correct as well as not expired when you come to the course. If you have to renew your permit before the course, you must come to the course with ALL the copies of the permit. Remember to check your expiration date before coming to the class. If your permit is expired or not validated, we cannot let you take the class, and you may forfeit the fees paid.**
